In order to receive the Notice and Annual Report in electronic mode, Members are requested to register / update their email addresses with the Depositories through the concerned Depository Participants in respect of shares held in electronic mode and with KFin at Selenium, Tower-B, Plot No. 31-32, Gachibowli, Financial District, Nanakramguda, Seriligampally, Hyderabad, Rangareddy, Telangana, India - 500 032 in respect of shares held in physical mode by submitting Form ISR-1 which is available on website of the Company at https://www.dfpcl.com/forms.

The Company is providing remote e-voting facility ('remote e-voting') to all its members to cast their vote on all resolutions set out in the Notice of 44th AGM. Additionally, the Company is providing the facility of voting through e-voting system during the AGM ('e-voting'). Detailed procedure for joining the AGM and remote e-voting/e-voting for shareholders holding shares in dematerialised mode, physical mode and for shareholders who have not registered their email address is provided in the Notice of 44th AGM. Members can attend and participate in the AGM through the VC/ OAVM facility only. Members who attend and participate in the AGM through VC/OAVM will be counted for the purpose of reckoning the quorum under Section 103 of the Act.

Pursuant to Section 91 of the Companies Act, 2013 read with Rule 10 of the Companies (Management & Administration) Rules, 2014 and Regulation 42 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Register of Members and the Share Transfer Books of the Company shall remain closed from Wednesday, 4th September, 2024 upto Tuesday, 10th September, 2024 (both days inclusive) for the purpose of 44th AGM of the Company and payment of dividend for the financial year ended 31st March, 2024, if declared by the members at their 44th AGM. SEBI has made it mandatory to use the bank account details furnished by the Depositories and the bank account details maintained by the RTA for payment of dividend to the Members electronically.
